For municipalities that require an invoice to process the membership fee, an invoice is attached for your convenience.

The membership fee entitles qualified individuals* in your organization to attend WMPF training programs free of charge – including, but not limited to, the annual Land Use Training Institute and planning and zoning seminars. **Municipalities may approve attendance at these programs as satisfying the New York State annual requirement for four hours of training for Planning and Zoning Board members.** Member municipalities will also be invited to nominate projects and citizen planners for WMPF’s annual planning awards.

We encourage land use professionals, municipal staff, elected officials and zoning, planning, architecture, historic preservation, and environmental board members to **visit our website** to access land use planning resources including videos of recorded training sessions that can be watched for credit towards the NYS required continuing education for Municipal Planning and Zoning officials.
